

Ahha Tulsa Creative Camp Waivers & Releases

Cancellation Policy

Ahha Tulsa reserves the right to cancel a creative camp due to low enrollment or other conflicts. If cancellation occurs, registered participants will be contacted by ahha staff and offered a full refund or a transfer to another creative camp, if available.

Liability Waiver

I understand and acknowledge that participation in the camps, events, or programs operated or conducted by ahha Tulsa (the Arts & Humanities Council of Tulsa, Inc), including all of its activities and the use of its facilities and equipment, involves an inherent and unavoidable risk of injuries, harm, and loss. I understand that although ahha Tulsa takes precautions to provide proper organization, supervision, and equipment, it is impossible for the organization to guarantee absolute safety. I understand there are numerous risks associated with participating in creative camp activities, including, but not limited to, outdoor play, painting, working with clay, camp-provided food, sewing, soldering, etc. Equipment used in activities may break, fail, or malfunction and cause injury. Some of the equipment used in activities may cause injuries even when used as intended. These are some, but not all, of the risks inherent in creative camp activities; a complete listing of inherent risks is not possible and some risks cannot be anticipated.

I authorize the child named in this registration to participate in the camps and all activities operated by ahha Tulsa, both on and off site. On my own behalf and on behalf of the child named in this registration, I ACKNOWLEDGE THE RISKS associated with participation in the creative camp and expressly and voluntarily assume the risks of participation in the camps and activities operated by ahha Tulsa and HEREBY WAIVE AND RELEASE ALL CLAIMS, DEMANDS, ACTIONS, CAUSES OF ACTION, COSTS, LOSSES, EXPENSES, AND LIABILITIES ("CLAIMS") (WHETHER ON BEHALF OF THE CHILD NAMED IN THIS REGISTRATION OR FOR MY OWN BENEFIT) AGAINST THE ORGANIZATION (INCLUDING ITS STAFF, EMPLOYEES, AND AGENTS) THAT MAY ARISE FROM INJURIES, HARM, OR LOSS RESULTING FROM PARTICIPATION IN THE CAMPS AND ACTIVITIES OPERATED BY THE ORGANIZATION, INCLUDING (WITHOUT LIMITATION) ANY CLAIMS ALLEGING NEGLIGENCE BY THE ORGANIZATION (INCLUDING ITS STAFF, EMPLOYEES, AND AGENTS), to the fullest extent allowed under the laws of Oklahoma. If any aspect of this waiver is deemed to be invalid, I acknowledge that the remainder of the agreement will continue to have full force and effect. If my agreement on behalf of my child to release their Claims against ahha Tulsa is deemed invalid for any reason, I agree to



indemnify, defend, and hold the organization harmless in connection with any Claims arising out of my child's participation in the camps, programs, events, and activities operated by ahha Tulsa, including payment of reasonable defense costs incurred by the organization.

I hereby authorize the staff of ahha Tulsa to act according to their best judgment in any situation requiring medical attention for the child named in this registration. I understand that it is my responsibility to provide medical insurance coverage for the child named in this registration while they are attending creative camps operated by ahha Tulsa and to provide accurate and complete medical information. I acknowledge that the costs of any medical treatment provided to the child named in this registration that are not covered by medical insurance will be my sole responsibility, consistent with the waiver of Claims above.

Ahha Tulsa reserves the right to expel or to deny re-enrollment or participation of any child if, in the organization's sole and absolute discretion, (i) the actions of a child or their parent/guardian disrupt, impede, or interfere with ahha Tulsa's ability to maintain a positive and constructive relationship with all participants and their parents/guardians (including but not limited to non-payment of camp fees), (ii) such actions threaten the safety of the child, other children, or staff, (iii) such actions otherwise interfere with the organization's accomplishment of its mission, or (iv) if expulsion or refusal to re-enroll would be in the best interest of the camper or ahha Tulsa. Ahha Tulsa will make every attempt to communicate with the child and their parent/guardian regarding any actions that would put a child at risk of expulsion or denial of re-enrollment. If, in its sole and absolute discretion, the organization decides to expel or refuse enrollment or participation to a child, any fees paid for unused days, if applicable, would not be refunded.

Photo & Video Release

As to any child who is enrolled in a creative camp operated by ahha Tulsa, I agree that the organization (including its staff, employees, and agents) can take and use photos, video, and audio recordings of the child named in this registration for the limited purposes of marketing ahha Tulsa which may be publicly available on the internet, without compensational obligation, and I hereby release ahha Tulsa (including its staff, employees, and agents) from any Claims resulting from their use of photos, videos, and audio recordings. If you do not want photos or videos of your child to be used in ahha Tulsa marketing materials, you must email learn@ahhatulsa.org to let staff know.



Further, I acknowledge and agree that the child and myself and any co-parent or co-guardian, are not allowed to take, and shall not take, any photographs, video, or audio recordings of other children or other parents/guardians participating in camps, events, or programs without their express consent, and are not allowed to transmit, upload, or post such content online or electronically including on any social media or similar site, or use or publish such content in any non-personal media such as a book, video, film, television program, or publicly viewable website. Upon ahha Tulsa's request, I agree to delete and/or remove such content from any device, site, platform, or other media, if, in the organization's sole and absolute discretion, such content and/or the manner in which it is presented violates the terms of this agreement, is objectionable, inappropriate, or violates the privacy rights or right of publicity of others.

COVID-19 Policy

I acknowledge the contagious nature of the Coronavirus/COVID-19 and that the CDC and many other public health authorities recommend practicing social distancing, frequent hand washing, and wearing face masks to prevent transmission.

I further acknowledge that ahha Tulsa has put in place preventative measures to reduce the spread of the Coronavirus/COVID-19 and that the child named in this registration, as well as all parents and caregivers entering the building, are required to follow the organization's policies regarding COVID-19. These policies include frequent hand washing and hand sanitizing, maintaining at least 6 feet apart from others when possible, and wearing a solid mask that covers the nose and mouth for ages 5+. I understand that ahha Tulsa will ask anyone not complying with these public safety measures to leave the building immediately and that my child will not be able to participate in camp if he/she/they do not comply.

I further acknowledge that ahha Tulsa cannot guarantee that my child will not become infected with the Coronavirus/Covid-19 during creative camps.

I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself, my child, and others, including, but not limited to, ahha staff, teaching artists, other program participants, and guests of the arts center.

I acknowledge that my child's risk of exposure to the Coronavirus/COVID-19 may be increased by participating in an ahha Tulsa program. I acknowledge that my child and all



caregivers must comply with all set procedures to reduce the spread while my child is a creative camp participant.

I attest that, during the duration of camp, my child will not attend if:

- My child is experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- My child been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- My child has been diagnosed with Coronavirus/Covid-19 and not yet cleared as non- contagious by state or local public health authorities.

I hereby release and agree to hold ahha Tulsa harmless from, and waive on behalf of myself, my child/children, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself, my child/children, and/or property that may be caused by any act, or failure to act of ahha Tulsa, or that may otherwise arise in any way in connection with any services received from ahha Tulsa. I understand that this release discharges ahha Tulsa from any liability or claim that I, my child/children, or any personal representatives may have against ahha Tulsa with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from ahha Tulsa. This liability waiver and release extends to ahha Tulsa (the Arts & Humanities Council of Tulsa, Inc) together with all owners, partners, and employees.
